Brian DiSabatino is a partner in the Delaware based construction firm, EDiS. His career has included posts in estimating, accounting, and project management. Currently, Mr. DiSabatino is the President of EDiS Building Systems, and Vice President of EDiS Company. His responsibilities include business development for all of the EDiS companies (EDiS Company, EDiS Building Systems, EDiS Development, EDiS Interior Construction and Asset Management Alliance), the operation of EDiS Building Systems, and the corporate strategic planning.

In his professional capacity, Mr. DiSabatino has overseen the planning and implementation of the companies' plans for the sales, revenue, and geographic growth. In the past ten years, EDiS Company has increased sales from \$80M to nearly \$175M while maintaining a repeat business ration of over 93%. EDiS has been repeatedly recognized as on of the Top Construction Managers as ranked by Engineering News Record Magazine. He is currently the Chairman of the St. Francis Hospital Foundation and an Executive Committee member of the St. Francis Hospital Board of Directors. The St. Francis Hospital Foundation created funding for this reemergence and has raised over \$30 Million to date.

In addition to St. Francis, Mr. DiSabatino is Vice Chairman of the Grand Opera House, Vice Chairman of the Chester County Chamber of Commerce in Malvern, PA and is a member of the Board of Directors of the Delaware Contractors Association. Mr. DiSabatino is also a Trustee of the American College in Dublin, Ireland.
